

OREGON COASTAL QUILT GUILD EXECUTIVE MEETING JULY 16, 2020

The Executive Committee meeting on July 16, 2020 was held on ZOOM and called to order at 10 a.m. by Vice-President Meralee Wilson.

Approval of minutes – Maria Hunter moved that the minutes of the June Executive Board Meeting be approved as published. Motion was seconded by Nan Scott and approved by a raised hand vote.

Old Business

2020 Raffle Quilt - Rosanne Berton reported that there are currently 50 envelopes of tickets that have not been returned. Members will be emailed and called to remind them to return tickets and money. The quilt is currently on display at Quilters Cove. The drawing for the quilt will be held on Saturday, August 8th at 3pm as printed on the tickets. The event will be at Atonement Lutheran Church in their backyard. People in attendance will be asked to stand 6 feet apart and wear masks. Jane Szabo reported the drawing will be held live on Facebook. Jean Amundson will do articles for News Lincoln County and the News Times. Set-up will be under overhang at the meeting room door, Meralee will get the ticket drum, table and quilt hanger from storage. Set-up at 2pm with drawing at 3pm. Tickets will be sold up to the time of the drawing. Jane will have her cell phone so winner can be called.

Facebook Ads – Jane Szabo reported that an ad on the BLOG or Facebook page is \$25. Nan Scott moved that advertisers be allowed on the website and Facebook page for a fee of \$25.00. Motion was seconded by Maria Hunter and passed by a hand vote. Advertisers will be sent an invoice from the treasurer.

We now have 3 small quilts made from the porch drop house block challenge. Thanks Jean! There are 5 blocks left to be set into a quilt. I'm looking for volunteers! They also need to now be quilted.

Ruth's Family Fabrics in Waldport closed their doors effective 7/17. On 7/21, we moved all our fabric and tools from Ruth's to a room that has been so generously donated to us in Lee Palmer's Tax Service building, also in Waldport. Veteran's Quilt Project will be sharing this space with us, and Twy relocated her supplies into this new space also. As we are not meeting right now, we are just using this as storage space, but plan to conduct our monthly meetings here when we can do that again.
